CITY OF LAWRENCEBURG

February 11, 2021

The Board of Mayor and Council met in regular session. The meeting was also held by teleconference. The following members were present: Council Member Sevier, Council Member Williams, Council Member Fox, Mayor Lay and Council Member Moore.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the January 14, 2021 Council Meeting was made by Council Member Fox with a second by Council Member Williams. Motion passed unanimously.
