CITY OF LAWRENCEBURG

May 9, 2019

The Board of Mayor and Council met in regular session. The following members were present: Mayor Lay, Council Member Fox, Council Member Williams, and Council Member Sevier. Council Member Moore was absent.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the April 15, 2019 Council Meeting was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.
