

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG

August 9, 2018

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Council Member Williams, Council Member Sevier, Council Member Moore and Mayor Durham.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the July 26, 2018 Council Meeting was made by Council Member Williams, with a second by Council Member Moore. Motion passed unanimously.

City Administrator, Chris Shaffer, advised the Council of three new employees in the Police Department; Hannah Purser, Skyler Lopp, and Jason Jantke. Police Chief, Terry Beecham, elaborated on Officer Jason Jantke and the new program he brings. His drug dog trained by him will also become part of the Police Department and we will resume the Canine Program with a passive drug dog.

Fire Chief, Jay Moore, informed the Council about Charter Communications and Red Cross partnering with the State Fire Marshal's Office to install smoke detectors in homes in Lawrenceburg in honor of Jason Dickey's Memory.

A Public Hearing was held for Ordinance 1241. With no one wishing to address the Council concerning the Ordinance the Public Hearing closed with no comments.
