

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG

August 13, 2020

The Board of Mayor and Council met in regular session. The meeting was also held by teleconference. The following members were present: Council Member Sevier, Council Member Moore and Council Member Williams and Council Member Fox. Mayor Lay was absent.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the July 23, 2020 Council Meeting was made by Council Member Moore, with a second by Council Member Sevier. Motion passed unanimously.

Leon White addressed the Council concerning his trailer park on Holtsford Street. He wants to be able to place travel trailers on blocks to rent to the public. He does not want to put them on permanent foundations.

He was informed that would take a change to the Zoning Ordinance, which would have to be approved by the Planning Commission, before coming before the Council for approval.

LUS Financials for June 2020 were accepted.

A Public Hearing was opened concerning the passage of Ordinance 1294, with no one wishing to address the Council, the Public Hearing closed.
