

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG

August 27, 2020

The Board of Mayor and Council met in regular session. The meeting was also held by teleconference. The following members were present: Council Member Sevier, Council Member Moore and Council Member Williams, Council Member Fox and Mayor Lay.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the August 13, 2020 Council Meeting was made by Council Member Fox, with a second by Council Member Williams. Motion passed unanimously.

City Administrator announced the closing of city offices on September 7, 2020 in observance of Labor Day.

Leon White went before the Planning Commission with his request to have the Building Code amended in order for him to use travel trailers as rental property. The Planning Commission voted to send his request to the City Council with a negative recommendation. He later decided he would not pursue his request and asked that the City Council remove it from the agenda.
