Motion to approve on second and final reading was made by Council Member Williams, with a second by Council Member Moore. Motion passed unanimously.

Motion to approve was made by Council Member Moore, with a second by Council Member Williams. Motion passed unanimously.

A RESOLUTION FOR THE BOARD OF COUNCIL OF THE CITY OF LAWRENCEBURG TO ENTER INTO A CONTRACT WITH BLUECROSS BLUESHIELD OF TENNESSEE, INC. FOR EMPLOYEE HEALTH INSURANCE

Motion to approve was made by Council Member Moore with a second by Council Member Williams. Motion passed unanimously.

Council Member Fox asked "How much did our insurance increase this year?" Judy Hartsfield answered that it has been reduced by 4.79%." When asked why, she replied "some of the taxes have been taken away due to actions by President Trump."
